

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.madmailers.com and Market Access Direct, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Market Access Direct, LLC include www.madmailers.com and Market Access Direct. The Market Access Direct website is a ecommerce site. By using the Market Access Direct website, you consent to the data practices described in this statement.

Collection of your Personal Information

Market Access Direct may collect personally identifiable information, such as your name. If you purchase Market Access Direct's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Market Access Direct. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Market Access Direct website.

Market Access Direct encourages you to review the privacy statements of websites you choose to link to from Market Access Direct so that you can understand how those websites collect, use and share your information. Market Access Direct is not responsible for the privacy statements or other content on websites outside of the Market Access Direct website.

Use of your Personal Information

Market Access Direct collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Market Access Direct may also use your personally identifiable information to inform you of other products or services available from Market Access Direct and its affiliates. Market Access Direct may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Market Access Direct does not sell, rent or lease its customer lists to third parties.

Market Access Direct may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Market Access Direct, and they are required to maintain the confidentiality of your information.

Market Access Direct will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Market Access Direct or the site; (b) protect

and defend the rights or property of Market Access Direct; and, (c) act under exigent circumstances to protect the personal safety of users of Market Access Direct, or the public.

Use of Cookies

The Market Access Direct website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Market Access Direct pages, or register with Market Access Direct site or services, a cookie helps Market Access Direct to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
